# Minutes Meeting on February 27, 2025, 6:30 p.m.

#### **OLD BUSINESS**

- Natural Resources Mapping update Friedman reported that he, Mellor and Rubendall met with Steve Lamonde of Moosewood Ecological for training on how to use Gaia GPS mapping tool. The training went well and the tool will be used walk and document the trails while walking at the various conservation land. The trails will then be another layer on the Natural Resources Mapping application.
- Conservationist of the Year update Dickler reported that the Commission will have Brian Colleran at the March 27 meeting where he will make a presentation to the public on invasive plants. Prior to Colleran's talk and discussion, Drouin will present the 2024 Conservationist of the Year Award. Dickler is working on news announcement about the presentation and award.
- Conservation Land & Related
   Trail Stewards update Rubendall explained his postings to recruit Trail Stewards for each of the conservation lands. So far, he has five volunteers to serve as Trail Stewards although there were three new volunteers in the audience. Trail Stewards will be recorded as Conservation Corps members with a separate email designation.

#### **NEW BUSINESS**

- Earth Day at Cathedral of the Pines, April 26 Lefebvre reported that there are now seven towns including Rindge that will attend and participate in Earth Day celebrations at the Cathedral. Tom Hsu of the Jaffrey Conservation Commission is organizing the day and will convene a planning meeting with a representative from each participating commission. Presently the following towns will participate in event: Rindge, Jaffrey, Dublin, Peterborough, Troy, Marlborough and Stoddard.
- UNH Wetlands Classification Workshop Saturday June 14 (9:00 3:30), Portsmouth. Members interested should sign-up. The Planning Director has indicated an interest in attending if schedule permits.
- Conservation Commission website and story maps Mellor explained the positives use of story maps for the public. The maps would be incorporated into the Natural Resources Mapping initiative. He thinks it will provide more information. The Commission had questions about cost and implementation timing. The Commission viewed different Commission Commissions' story maps on the large screen in the room which was very helpful. The Commission thought story maps was a positive suggestion but as it had a lot on its 2025 agenda, decided to put the project on track for 2026. There is online training available for interested members at about \$59 each which might be helpful to learn how to develop story maps and guide the path to future implementation. Rubendall motioned and Rogers seconded to spend up to \$200 for training for those who wanted to take the course.
- Cheshire County Conservation District Mellor reported that the district has a grant to assess turtle crossings in the district this summer.
